This is with reference to the captioned subject in connection with the non- applicability of Regulation 24A of SEBI (listing Obligations and Disclosure Requirement) (Amendment) Regulations. 2018. In this regard, We would like to submit that Securities and Exchange Board of India vide its circular no CIR/CFD/CMDI/27/2019 Dated 8th February, 2019 prescribed the format of Annual Secretarial Compliance Report to be submitted by a Company Secretary in Practice to the Listed Entity on Compliance of all applicable SEBI Regulations and circulars/ Guidelines issued there under and this Report shall be submitted by the listed Entity to the stock Exchanges within 60 days of end of the Financial year.

Your good self-please note that vide circular Nos. LIST/COMP/10/2019-ZO dated 9th May2019 and LIST/COMP/12/2019/-20 dated 14m May 2019. respectively has clarified that the above stated compliance of submission of Annual Secretarial Compliance Report is not applicable to listed Entities which have claimed exemption under regulation 15 (2) of SEBI (LODR), 2015.

In this regard, we respectfully submit that as our Company falls under the criteria as specified under Regulation 15 (2) of the SEBI (LODR) Regulation 2015 due to fact that the paid-up equity Share Capital and Net Worth of the Company was Rs. 499.96/- Lacs and Rs 1068.51 Lacs respectively as in the previous financial year.
