Sec'bad-Tirupati Vande Bharat to run faster with more passengers

Hyderabad, May 16 (IANS) The passenger capacity of the Secunderabad - Tirupati - Secunderabad Vande Bharat Express will be more than double to 1,128 and the train will travel faster from Wednesday.

The train which was travelling with eight coaches and 530 passenger capacity is being enhanced with revised composition of 16 coaches and 1,128 passenger capacity from May 17.

The South Central Railway (SCR) announced that the travel time in both the directions is also being reduced by 15 minutes and the train will complete its journey in either direction in 8 hours 15 minutes, instead of the present duration of 8 hours 30 minutes.

The railways have taken the decision to increase the

coaches keeping in view the heavy passenger demand for the train.

Prime Minister Narendra Modi flagged-off by the train on April 8.

According to SCR, the Train No. 20701/20702 Secunderabad - Tirupati - Secunderabad Vande Bharat Express was initially introduced with 8 coaches' composition, which included 01 Executive Class and 07 Chair Cars. Since the introduction of the regular services, the train has been operating with more than 100 per cent patronage consistently.

While, the Train No. 20701 Secunderabad - Tirupati Vande Bharat Express recorded a patronage of 131 per cent in April and 135 per cent in May, the Train No. 20702 Tirupati - Secunderabad Vande Bharat Express recorded a patronage of 136 per cent in April and 138 per cent in May. In terms of number of passengers, till May 15, a total of 44,992 passengers have availed Vande Bharat Train service in both direc-

tions. While 21,798 passengers have travelled by Vande Bharat Express from Secunderabad to Tirupati, another 23,194 passengers have travelled from Tirupati to Secunderabad. Both the categories of coaches - Executive as well as Chair Car have witnessed more than 100 per cent patronage in both directions.

The new composition will have 14 Chair Cars with 1,024 capacity (instead of earlier 6 with a capacity of 478) and two Executive Class with 104 capacity (instead of earlier one coach with a capacity of 52).

Arun Kumar Jain, General Manager, South Central Railways has said that the doubling of the coaches is also a timely addition, as during this summer holiday season more passengers will be able to visit Tirupati.

To accommodate the reduced travel time, the train timings at stations have also been revised with effect from May 17. The train enroute stops only at four stations - Nalgonda, Guntur, Ongole and Nellore. -IANS

Business Brief

Argentina raises interest rate to 97%, inflation rate at 100%

Buenos Aires, May 16 (IANS) The Central Bank of Argentina raised its key interest rate by six percentage points to 97 per cent in an effort to tackle soaring inflation that has reached 30-year highs.

Central banks across the globe are struggling to rein in inflation, but it's a particular problem in Argentina, where the annual inflation rate soared above 100 per cent last month, CNN reported.

That's the highest level since the early 1990s, and currently, Venezuela and Zimbabwe are the only two countries experiencing higher inflation than Argentina, according to International Monetary Fund data.

In a statement on Monday, the central bank also said that it is hoping the rate hike will incentivise investments in the country's currency.

The exorbitant inflation resulted in large outflows of investments held in the Argentine peso, leading to a 23 per cent decline in its value against the US dollar this year.

Ahead of a presidential election set for October, Economy Minister Sergio Massa is focused on avoiding an even bigger devaluation of the currency and containing inflation.

U.P NOW HOLDS SECOND POSITION IN GI TAGGED PRODUCTS

Varanasi (UP), May 16 (IANS) Uttar Pradesh now holds second position in the country in terms of having the maximum number of Geographical Indication-tagged goods after receiving GI tags for three more ODOF crafts.

The ODOF crafts that have received GI tags include Mainpuri tarkashi, Mahoba Gaura stone craft, and Sambhal horn craft.

While Tamil Nadu leads with 55 GI-tagged goods, UP and Karnataka follow with 48 and 46 GI products, respectively. However, UP is first in terms of GI-tagged handicrafts with 36 crafts to its credit. "With this feat, UP, beating Karnataka, has become the second state with maximum GI-tagged goods in the country. UP also has the maximum number of GI tags in handicrafts in the country," said GI expert Rajni Kant, a Padma Shri awardee, and head of Human Welfare Association (HWA) that facilitated these handicrafts to get the GI certification. According to him, of the 48 GI goods of UP, 36 products belong to the handicraft category.

India Inc gives 2% stipend hike in FY23, Chennai leads

New Delhi, May 16 (IANS) The average stipend pay outs witnessed a 2 per cent marginal increase in India in FY23 compared to the previous fiscal, and top-paying cities were Chennai (Rs 13,100 per month) and Kochi (Rs 13,000 per month) on average, a report showed on Tuesday.

These cities were followed by Bengaluru and Coimbatore, both offering Rs 12,900 per month on average as apprentice stipend.

Additionally, Nagpur and Lucknow saw a 9 per cent increase in stipends, while Chandigarh had a 6 per cent increase and Delhi

and Hyderabad each had a 5 per cent increase in stipend, according to a



TeamLease Degree Apprenticeship report.

"Incidentally, stipend growth in India has outperformed salary growth in many industries, with many industries paying higher

than the minimum notified stipend," said Sumit Kumar, Chief Business Officer, TeamLease Degree Apprenticeship.

Employers are willing to pay higher stipends than industry mandates as they see the value of investing in apprentices to bridge the skill crisis and create a sustainable talent supply chain, he added.

While the overall percentage increase has been a marginal spike, the findings highlighted a significant variation in stipend pay-

outs across industries, cities and educational qualifications.

Jobs roles with highest stipends are agriculture field officer (Rs 15,200 per month), retail sales (Rs 13,800 per month) and HR (Rs 13,600 per month).

Agriculture and agro-chemicals, with current stipend of Rs 14,000 witnessed a 12 per cent growth.

In the services sector, 11 out of 13 industries provided a higher stipend in the fiscal. The top industries included media and entertainment (18 per cent), Services including repair and maintenance (11 per cent), education (9 per cent), life science (8 per cent) and e-commerce and tech products (8 per cent).

ZestMoney founders quit as fintech startup fails to raise capital

New Delhi, May 16 (IANS) The founders of ZestMoney, India's digital EMI financing platform, have reportedly resigned as the Goldman Sachs-backed fintech startup has failed to raise fresh capital.

According to a TechCrunch report, its founders Lizzie Chapman, Priya Sharma and Ashish Anantharaman informed employees about their decision via an email.

"Over the last few weeks, we have done a lot of thinking and it has been hard for us to arrive at this conclusion. We have immense belief and faith in the potential that ZestMoney has," the founders wrote.

Yellen reiterates US could default on debt by early June

Washington, May 16 (IANS) In a letter to Congressional leaders, US Treasury Secretary Janet Yellen reiterated that the country could default on its debt obligations as early as June 1.

The Department of Treasury will likely no longer be able to satisfy all of the governments' obligations if Congress has not acted to raise or suspend the debt limit by early June, and potentially as early as June 1, Yellen said in the letter sent on Monday.

She made the assessment after obtaining additional information on the latest data, and federal receipts, outlays, following her earlier letter of this kind on May 1, reports Xinhua news agency.

"Waiting until the last minute to suspend or in-

crease the debt limit can cause serious harm to business and consumer confidence, raise short-term borrowing costs for taxpayers, and negatively impact the credit rating of the US," warned Yellen.

"In fact, we have already seen Treasury's borrowing costs increase substantially for securities maturing in early June," she added.

If Congress fails to increase the debt limit, it would cause severe hardship to American families, harm US global leadership position, and raise questions about U.S. ability to defend its national security interests, according to the Treasury Secretary.

The second meeting between President Joe Biden and congressional leaders on budget and debt ceiling

will now take place on Tuesday. Biden and congressional leaders discussed the budget issue for the 2024 fiscal year last Tuesday but failed to generate meaningful breakthroughs.

Though Biden has expressed optimism on prospects of the second meeting, Republican House Speaker Kevin McCarthy said on Monday that there's been "no progress" on debt ceiling talks ahead of the meeting.

In January, the US hit its \$31.4 trillion debt limit, set in December 2021, prompting the Treasury Department to use accounting maneuvers known as "extraordinary measures" to keep the government paying its bills, such as curbing certain government investments.
