મ્યુલ બેંક એકાઉન્ટ કૌભાંડના નીરવ શાહના જામીન ફગાવ્યા

(એજન્સી) અમદાવાદ, કરોડો રૂપિયાના નાણાકીય કૌભાંડ અને મ્યુલ એકાઉન્ટસ ચલાવવાના ગંભીર કેસમાં આરોપી નીરવકુમાર રાજેન્દ્રભાઈ શાહની જામીન અરજી એડીશનલ સેશન્સ જજ જયેશકુમાર આર્ટ, પટેલે ફગાવી દીધી છે. કોર્ટે નોંધ્યું છે કે, આરોપીએ અન્ય સહઆરોપીઓ સાથે મળીને કાવતરું રચીને મોટા પ્રમાણમાં મ્યુલ

બેંક ખાતાઓ ખોલવાયા હતા. આવા મ્યુલ એકાઉન્ટની વિગતો આરોપીના જોખમી ઇમેઇલ ઇન્ટરવેલ ઓફિસના આ ખાતાઓનો ઉપયોગ કરીને નેટ બેંકીંગ અને મોબાઇલ બેંકીંગ દ્વારા મોટા પાયે શંકાસ્પદ નાણાકીય ટ્રાન્ઝેક્શન કરવામાં આવ્યા છે. પ્રાથમિક દરિએ આરોપી આ આખા મ્યુલ એકાઉન્ટ નેટવર્કનો મુખ્ય સ્થાનીક ઓપરેટર હોવાનું જણાય છે.

આ કેસની તપાસ હજુ ચાલુ છે. અને અન્યત્ર મહત્વના તબક્કે છે. ગુનાની ગંભીરતા અને ડીજીટલ પુરાવાઓને જોતાં આરોપીઓને જામીન આપી શકાય નહીં. કરોડો રૂપિયાના નાણાકીય કૌભાંડ અને મ્યુલ એકાઉન્ટસ ચલાવવાના ગંભીર કેસમાં આરોપી નીરવકુમાર રાજેન્દ્રભાઈ શાહની નારણપુરા પોલીસે ધરપકડ કરી હતી.

મળતી માહિતી મુજબ મુતકની ત્રણ ટિકરી અને એક ટિકરી છે જેથી જતિ સહિત આખા પરિવારનો મોબ ખતો રહ્યો હોય તેવી લાગણી ખેડ મોતીપુરા ગામમાં રહેતા પરિવારે અનુભવી છે. સમગ્ર ઘટનાને લઈને આપુ ગામ શોકાતુર બની ગયું છે. હવે પ્રશ્ન એ થાય છે કે સાબરકાંઠાનું પોલીસ તંત્ર વ્યાજખોરો સામે કડક કાર્યવાહી કરવાની બુમો પાડે છે ત્યારે ખેડ મોતીપુરા ગામને લીધે આ ઘટના બાદ પોલીસ ફરીયાદ નોંધાયા પછી પોલીસ તંત્ર કેવી કાર્યવાહી કરે છે તે અંગે હાલના તબક્કે કંઈપણ કહેવું વહેલું છે. જો વ્યાજખોરો સામે દેખાવ પુરતી કાર્યવાહી કરીને પોલીસ તંત્ર સંતોષ માનશે તો હજુ પછા ભવિષ્યમાં અનેક પરિવારો વ્યાજખોરોના ત્રાસથી કંટાળીને આજીવનુ પગલુ ભરે તો નવાઈ નહીં.

Notes:-

- The above standalone and Consolidated audited financial results have been reviewed by the Audit Committee and thereafter approved by the Board of Directors of the Company in their respective meetings held on May 30, 2026. The audit as required under Regulations 33 of SEBI (Listing Obligation and Disclosure Requirements) Regulations, 2015 has been completed by the statutory auditors of the company.
- The standalone and Consolidated audited financial results for the quarter and year ended March 31, 2026 have been prepared in accordance with the Companies (Indian Accounting Standards) Rules, 2015 (Ind AS) prescribed under section 133 of the Companies Act, 2013 and other recognized accounting practices and policies to the extent applicable.
- During the previous financial year 2023-24, Interim Order were received from the Securities and Exchange Board of India ("SEBI") alleging non-compliance of provisions pertaining to wrongful gains transactions, the Company had consulted an independent law firm, and in its replies to SEBI, the Company has denied the charges in its entirety, inter alia, on the basis that these transactions are in full compliance with the prevailing laws and regulations. Company gone for appeal to challenge SEBI Interim order.
- Pending outcome of the adjudications, the Company holds its view of the validity of the nature and effect of the transactions. Accordingly, no adjustments have been made in the financial statements of the Company. Management is in the process of ascertaining the legal position of the Company for the possible cash outflow and its consequential impact on these Standalone Financial Statements.
- Based on the nature and scale of activities carried on by the Company during the year, the provisions relating to registration under Section 45-IA of the Reserve Bank of India Act, 1934 may become applicable to the Company. The management has represented that the matter is under evaluation and appropriate steps, consultations and regulatory assessments are being undertaken in this regard. Pending completion of such process, the Company has not obtained registration under the aforesaid provisions as at March 31, 2026.
- The Company/Group has not generated any revenue from operations during the year ended March 31, 2026 and continues to primarily depend upon other income comprising interest income, dividend income, and income from investments for sustaining its operations and meeting its financial obligations. Further, the Company has incurred cash losses during the current and previous financial year and is also subject to ongoing SEBI proceedings as referred in Note 3 above. These conditions indicate the existence of material uncertainty which may cast significant doubt on the Company's ability to continue as a going concern. However, the accompanying standalone financial results have been prepared on a going concern basis considering management's assessment of future business plans, realizable value of investments and financial support available to the Company.
- The Company/Group operates in a single segment and in line with Ind AS - 108 - "Operating Segments", the operation of the Company fall under only one Business which is considered to be the only reportable business segment.
- The Figures for the quarter ended March 31, 2026 and March 31, 2025 represent the difference between the audited figures in respect of the full financial year and the unaudited published year-to-date figures upto the third quarter of the respective financial year, which were subjected to limited review.
- The figures for the previous period has been regrouped / re-arranged to make them comparable with the current period figures.
- Consolidated audited financial results for the quarter and year ended March 31, 2026 includes results of its subsidiary - Subsidiary Company - Tradeed Enterprises Private Limited (Formerly Known As Tradeed Financial Services Private Limited)

Tanking up: Fuel demand surges 43% in Gujarat

Ahmedabad: Gujarat experienced a major surge in fuel demand during the first 28 days of May, with retail diesel sales climbing 42.6% compared to the same period last year. This rapid growth has prompted public sector oil marketing companies, including IndianOil, Bharat Petroleum, and Hindustan Petroleum, to scale up their logistics and supply operations to prevent shortage.

According to data released by these three state-run fuel retailers, diesel sales in the state jumped to 6.26 lakh kilolitres between May 1 and May 28, up from 4.39 lakh kilolitres during the identical timeframe last year. A district-wise analysis reveals that Kutch experienced the highest growth rate, with diesel consumption soaring by 75.9%. Other districts with massive growth included Botad at 72.3%, Gir Somnath at 72.2%, Banaskantha at 69.4%, and Junagadh at 64.1%. These areas easily outpaced the state average, indicating robust demand across farming and manufacturing zones alike.

Among districts, Kutch recorded the highest growth in diesel consumption at 75.9%, followed by Botad (72.3%), Gir Somnath (72.2%), Banaskantha (69.4%) and Junagadh (64.1%).

JD-U hits out at Rabri Devi over bungalow row

Patna, May 30 (IANS) A fresh political controversy has erupted in Bihar over the government bungalow at 10 Circular Road in Patna after former Chief Minister and Leader of the Opposition in the Bihar Legislative Council, Rabri Devi, reportedly refused to vacate the residence despite receiving a final notice from the state government. According to reports, the Bihar government issued a final directive asking Rabri Devi to vacate the bungalow. However, she has maintained that she will not leave under any circumstances, challenging the government to use security forces if it wishes to evict her.

Amidst the proceedings, Patna Secretariat SDPO Anu Kumari arrived at the residence accompanied by a police force and held a conversation with Rabri Devi.

Bihar Deputy Chief Minister Vijay Kumar Chaudhary emphasised that all administrative actions are carried out strictly in accordance with established laws and regulations. He said every citizen is expected to comply with legal provisions and government rules, adding that decisions regarding official residences are governed by prescribed norms and procedures. Meanwhile, JD(U) Chief Spokesperson Neeraj Kumar launched a strong attack on Rabri Devi over the issue. He questioned the basis of her objections, claiming she had already been allotted an alternative government residence and that additional arrangements were also available.
